Herewith we transfer the approval as "BMW Longlife-04" oil, given for "Infineum IME 1304749-A", SAE 5W-30, engine oil code "IME 1304749-A" of "Infineum" to the Reblend oil "KENNOL ECOLOGY 5W30 C3", SAE 5W-30 (oil code IME 1304749-A) of ACCOR LUBRIFIANTS. Consequently it is approved according to our release procedure for BMW Longlife engine oils (7th edition, 2016) for the usage in BMW engines operating in compliance with our operating fluids manual.

This confirmation is valid for two years beginning with the date of this letter and can be extended no more than two times for a maximum of two years in each case. Prolongations have to be requested within BFAS (BMW Fluid Approval System), the extension date can be taken from BFAS, reference EOA-RBR-2016-00359.


Engine oils produced using the code or brand names mentioned in this letter of confirmation have to comply with the tested oil sample in every respect. Any proposed alteration or modification to the lubricant has to be supplied to BMW within BFAS whereby a new approval may be granted.
